  - (c) Proof of legal entity, such as articles and memorandum of association and in case of a

- registered company, partnership deed or a certificate of HUF in case of a coparcenaries property.
- (d) Proposed Lay-out Plan/map/building plan of Tourism Unit prepared and certified by a Registered consultant/architect.
- (e) Title deed, such as the latest Zamabandi of the Revenue Department, or a lease deed, or a sale deed, manifesting proprietary/ownership rights of the property in question.
- (f) No Objection Certificate (NOC) of Forest Department, in case the tourism unit in question is in the vicinity of a national park, wildlife sanctuary or a forest reserve/forest area.
